The summer school “Corporate Governance and European Integration” will focus on variety of theories, empirical evidence and policy debates on corporate governance provided by a team of highly experienced researchers in the field of economics, law and finance. Lecturers include: Dennis Mueller (University of Vienna), Miguel Garcia-Cestona (Universitat Autònoma de Barcelona), Joze Damijan (University of Ljubljana), Marc Goergen (IE Business School), Klaus Gugler (Vienna University of Economics and Business), Johanna Palmberg (Södertörn University), Evgeni Peev (Vienna University of Economics and Business), and Martin Winner (Vienna University of Economics and Business).

Students will learn about basic issues of the current European corporate governance debate (convergence to the Anglo-Saxon corporate governance model, takeovers in EU law, corporate governance specifics in Scandinavian countries, corporate governance in the EU New Member States in Central and Eastern Europe, IPOs, board of directors, dividend policy in regulated industries and the like).
